

# BONNET CLEANER

## LEMON-SCENTED, SOLVENT EMULSION CLEANER

### DESCRIPTION:

BONNET CLEANER has been specifically designed for use with carpet bonnet cleaning systems. A unique combination of solvents effectively loosens soils and emulsifies greases for ready absorption. A pleasant orange fragrance leaves the carpet with a clean, fresh scent.

### APPEARANCE:

Semi-viscous white emulsion with strong lemon-citrus scent.

### pH:

8-8.5

### DILUTIONS:

Always shake concentrate before using. Stir diluted solution occasionally during use. Dilutions are as follows: Light cleaning at 1 part cleaner to 8 parts water; Regular cleaning at 1 to 6; Heavy soil at 1 to 3. Always test for colorfastness before use.

### DIRECTIONS:

Method #1: Place diluted solution in bucket and immerse bonnet in the solution; then wring out very dry with down-press wringer. Position bonnet under brush and scrub carpet clean. Soil will transfer from carpet to pad; turn pad over when soiled. Immerse pad in solution, wring out, and repeat. Change solution when dirty.

Method #2: Spray diluted solution on carpet in sections of approximately 3 feet in width. Moisten bonnet in cold water, place under machine, then scrub until dirt transfers onto bonnet; continue

overlapping until area is clean. Bonnet can be rinsed in water, wrung out, and used continuously.

Spotting: Dilute 1 to 3 with cold water in a spray bottle; shake well. Spray on the spot and blot with damp absorbent cloth. (Allow 3 to 5 minutes for chemical action.)

Manual cleaning of traffic lanes and stairways: Apply diluted solution with a moderately wrung short cotton mop with side to side action to remove soil. Rinse dirty mop in water, then saturate with solution and repeat.
