DESCRIPTION:

Newly revised SAF-DEE is a powerful ready-to-use cleaner that quickly and effectively removes scale and hard water buildup (lime, calcium, scale), rust, algae discoloration, and soap scum deposits from horizontal and vertical surfaces.

FOR USE ON:

Toilet bowls, urinals, shower walls, bed pans, autoclaves, drinking fountains, chrome fixtures, vitreous china, ceramic enamel, stainless steel, copper, bronze, brass, chrome and chrome plate, steam tables, dish washing machines, swimming pools, and many others.

CAUTION: SAF-DEE'S low pH could have deleterious effects on some surfaces. If there is any doubt as to SAF-DEE's compatibility on a particular surface, check a small inconspicuous area first by allowing a small amount of SAF-DEE to sit on it for a few minutes and then rinsing thoroughly with water. If any discoloration occurs, there is a possibility that some damage to the substrate could occur with further usage; however, SAF-DEE may also be diluted and applied for a shorter period of time with good results, but test first.

APPLICATION:

TOILET BOWLS and URINALS: Use full strength directly on a bowl mop and swab inside of bowl (stubborn stains may require rubbing or a second application). Allow to dwell for 3-5 minutes,

brush again, then flush. Pour 2 oz. of SAF-DEE into clean water and with the bowl mop, clean outside seats and outside of fixtures. Rinse thoroughly.

SHOWER STALLS and FIXTURES: Dilute SAF-DEE with 1-3 parts of water, apply to surface with sponge or swab, wait 2-3 minutes then scrub and rinse well with clean water.

CAUTION: Do not let SAF-DEE remain on any surface longer than 10 minutes.
