#### **DIRECTIONS:**

For Cleaning Resilient Flooring: Dilute TUFF-KLEEN 1 or 2 oz. per gallon of water. Apply to surface with mop and allow to sit a few minutes, then pick up with wrung-out mop. No rinsing is necessary.

For Removing Old Wax From Floors: Dilute 6 oz. of TUFF-KLEEN in 1 gallon of hot water. Apply liberally to the floor with a suitable applicator and allow to sit for a few minutes. Scrub with floor machine and stripping pad, then pick up excess and rinse with clean warm water. Adding 1-2 oz. of BOBRICK'S AMMONIA to stripping solution will facilitate stripping.

For General Cleaning (Walls, Blinds, etc.): Add 1 to 2 oz. TUFF-KLEEN to a pail of warm water. With a sponge, clean area within reach, then wipe off with cloth or chamois dampened with the solution and wrung dry.

For Heavy Cleaning of Concrete Floors: Use 6 oz. of TUFF-KLEEN in a gallon of hot water. Apply to surface with suitable applicator and let sit. Next, machine scrub if necessary. Pick up soiled solution completely. No rinsing is necessary unless unusually heavy soil is present.

For Pre-Spotting of Heavily Soiled Carpets: Use 10% solution of TUFF-KLEEN in water prior to shampooing.
